TERMS AND CONDITION OF THE QUOTATION NOTICE

1. All the Covers containing quotations shall be sealed, Clearly superscribed “ Quotations for LAYING OF OPTICAL FIBER CABLES" underground at Kavaratti and such covers addressed to the Officer on Special Duty, CTOD, Kavaratti, shall be posted well in advance so as to reach the under signed within the date and time prescribed. Tenders received after the said date and hour will be rejected.
2. The last date of receipt of quotation is 1200 hrs 30.01.2012. The quotation will be opened at 1500 Hrs on the same day by the Officer on Special Duty, CTOD, Kavaratti in the presence of the intending quotationers, if any present at the time opening (1500 hrs on 30.01.2012).
3. An amount of Rs.5000/- (Five thousand) only is to be remitted along with the quotation by way of Demand draft drawn in favour of The Managing Director, LDCL, Kavaratti encashable at Syndicate Bank, Kavaratti as **EMD**. EMD in any other form is not acceptable. The offer made without EMD will be rejected. The EMD of the unsuccessful quotationers will be returned only after finalisation of the quotation.
4. The Contractor will be held responsible for loss/ damages of the property belongs to Government or private party, if any occurred while executing the work and he is bound to make good the loss / damage at his own risk and cost.
5. Vehicle, Tool or any other equipment required for the proper execution and completion of the work shall be arranged by the contractor at his own risk and cost.
6. The period of contract will be for 3 months from the date of issue of the formal work order. However the department can extend this up to six months at the same terms and conditions.
7. The Contractor or his representative should be in constant contact with the O.S.D. The address and Telephone number if any may be furnished to the under signed.
8. The quantity of the work mentioned are likely to be increased / decreased considerably
9. The contractor will be held responsible, if any delay is occurred for the completion of works with in the stipulated period given by the under signed or his representative from time to time. An amount equal to the loss sustained by the department owing to the delay shall be recovered from him.
10. The EMD of the contractor who backs out after awarding contract or half way between the currency of the contract shall be forfeited to the department.

- 11 The department does not bind itself to accept lowest or any other quotation and reserves the right for accepting the whole or any part of any offer and quotationers shall be bound to carry out the work at rate accepted by the department. The decision of the Managing Director, LDCL, Kavaratti will be final on this and the contractor is bound to obey the same.
- 12 No advance payment will be made at any circumstances and the offer demanding advance payment will not be accepted.
- 13 The validity of the rate quoted in tender shall be for a minimum a period of six months from the date of opening for acceptance.
- 14 In the event of cancellation or refused of the order by the contractor the work will be got executed by the department and EMD with the department will be forfeited.
- 15 The work should be carried out and completed to the utmost satisfaction of the undersigned or his representative. If the work is found sub standard or unsatisfactory. The contractor should do the work again to the satisfaction of the department with out any extra cost, or-else the work order will be cancelled and the EMD will be forfeited.
- 16 The department will keep ready all the materials required for the work at our store / yard and the contractor should arrange safe transportation to site and return the balance to the store/yard at his risk and cost. He is al so responsible for safe custody of all materials entrusted to him.
- 17 The rate shall be inclusive of cutting of concrete roads and laying of G. I. Pipes or PVC hose and transportation etc wherever necessary. The rate quoted shall further inclusive for laying cables in the existing trench below the cable in case of HT cable by removing cables, bricks etc wherever found necessary.
18. Broken portion of the concrete road should be reconditioned by the contractor and materials required for the work shall be arranged by the contractor at his own cost and risk
19. The contractor shall kept ready to take up the work at any time including odd hours in a day during the period of contract.

SPECIAL TERMS AND CONDITION AND SPECIFICATION

1. The Optical fiber cable should be laid on the route marked by the department Representative.
2. The contractor has to take care of the other UG cables belongings to ELE, Telecom department, water supply pipes, cable TV etc. already laid in the same route
3. The optical fiber cables should be buried at a depth of 95 cm from the upper surface of the Ground.
4. A thick layer of fine dry sand should be spread over and below the optical fiber cable Then place the wire cut bricks side by side across and above the cable.
5. While crossing roads, other cables etc. PVC/GI/Cement pipes has to be provided at the cross.
6. In the case of cable failure, the contractor must be capable to provide sufficient labours to execute the work even in very odd hours of the day including night hours.
7. The rate shall be quoted for one meter in the schedule of rate attached to the quotation documents and affix name, address in the place provided in the schedule.
8. The broken portion of the concrete road shall be reconditioned within the day itself. The materials like cement, granite stone and sand etc required for the work shall be arranged by the contractor at his own cost and risk.

4. A thick layer of fine dry sand should be spread over and below the optical fiber cable then place the wire cut bricks side by side across and above the cable.
5. While crossing roads, other cables etc. PVC/GI/Cement pipes has to be provided at the cross.
6. In the case of cable failure, the contractor must be capable to provide sufficient labours to execute the work even in very odd hours of the day including night hours.
7. The contractor should not leave debris or cable at site to cause any accident. Warning boards supplied by the department shall be displayed while working on road sides. Any accident occurred owing to the negligence of the contractor shall be the responsibility of the contractor alone.
